he founder of Subud,
Muhammad Subuh
Sumohadiwidjojo, was born
in Indonesia in 1901 and died in
1987. Bapak (father), as he was
affectionately known, spontaneously
received his first experience of a
spiritual practice (commonly referred
to as the *latihan kejiwaan* of Subud)
in 1925. Eventually, he understood
that the *latihan kejiwaan* was not just
meant for himself alone.

Following the spread of Subud to the West in 1957, Bapak traveled around the world many times, giving talks and explanations about this path.

Through this practice, each person may discover his/her own inner nature, potential, talent, and guidance in life, in accordance with his/her unique capacity and commitment.

Subud encourages the expression of an individual's qualities and talents, through the form of cultural expressions, enterprises, education, healthcare, and the support for those in need.

The international Subud organization exists to serve the member countries and to facilitate the development of Subud and its expression in the world. It organizes gatherings, disseminates talks by Bapak and Ibu Siti Rahayu, supports the acquisition of Subud premises, helper visits, publications, web sites, and access to and support for networks of Subud members.

The most notable aspect of 2022 has been the gradual return to normalcy, after two years of being impacted by the COVID pandemic.

This culminated in a very well organized and well attended joint Zone 3 and 4 meeting in Assisi, Italy.

Since then, there have been other large gatherings.

Occasionally, some attendees contract COVID, but it appears that this is now perceived as one of many other illnesses that are an unfortunate and undesirable, but inevitable affliction of human life.

Still, from what I hear, regular attendance at group *latihans* is not yet fully back to where it was, and I hope this changes. Group *latihans* are very important and cannot be fully substituted for by *latihan* at home. I urge all groups to make an effort to accommodate anyone still concerned so that we all benefit from group *latihans*.

An issue that is on many members' minds at the time of writing is the World Congress.

We had to postpone it by a year due to COVID. These delays frustrated some of you, and some also raised concerns about the logistical challenges of holding the congress in Kalimantan.

Many of us have our ideal picture of what a world congress should be like, and what it should be for. It is important for me here to point out a couple of points:

Please consider that your own ideal version of a World Congress may not be the same as someone else's, and also, that there is always a need to find a compromise between the needs of individuals and the need of the organization.

Lastly, there is really no reason to expect one world congress to be the same as another.

When we receive to have the World Congress in Kalimantan, it is to be expected and accepted that this means a different World Congress than it was if Freiburg, Puebla, Christchurch, etc.

We welcome the unique nature of each world congress and seek to understand what it is in the content of the congress that makes it different, rather than try to fit it to the mold of a past congress we particularly enjoyed

Please let us work together towards a congress that is an acceptable compromise to as many of us as possible, and let's welcome the change, the difference that would hopefully make this congress special.

Elwyn Waugh, WSA Accountant The WSA Executive Committee works closely with and supports the work of the World Subud Council (WSC), which is comprised of the WSA Chair, Zone Representatives (Board of Directors), International Helpers, and the Chairs of MSF, SDIA and SICA.

The Committee is responsible for the administration and dayto-day management of the organization, including finances, and manages and coordinates a range of services for the benefit of members, such as Translations, ICT and the WSA Care Support Program. The Committee also facilitates and oversees various working parties and sub-committees and is responsible for arranging the next World Congress in coordination with the World Congress Organizing Team (WCOT).

2022 HIGHLIGHTS

WSA *kejiwaan* **sessions**

SA *kejiwaan* sessions were held over weekends in February and July. The programs for each were prepared by the Area 1 and Area 2 International Helpers respectively. The Translations team provided subtitled videos of the selected Bapak's Talk (86 LON 2) for the February session in three languages (English, French and Spanish). The Zoom meetings were set up to facilitate simultaneous interpretation together with break out rooms for sharing and self-reflection in smaller groups after *latihan* and testing off screen.

Throughout the year, the International Helpers worked closely with the WSC members and the various Subud organizations and teams, providing *kejiwaan* support including testing and *latihan*.

WSC periodical meetings

Two WSC meetings were held over weekends in March and September via Zoom, and attended by the full council including International Helpers, international Subud organizations, WSA sub-committees and services. The sessions were broadcast live via YouTube for members to observe.

Both meetings provided the opportunity for the council members to provide updates, including International Helper travels, and for sharing about the activities of the international Subud organizations, Wings, and sub-committees. In September, the focus of the second day was the results of the Pre-Congress Survey (conducted during June-July 2022) and congress venue scenario options, which were presented by the Executive Chair and WCOT coordinator.

The third periodical planned for the year was moved to February 2023 to coincide with the in-person WSC meeting in Kalimantan.

RESPONDING TO THE UKRAINE CRISIS WITH TOGETHERNESS

The outbreak of the Russian-Ukraine war in February 2022, and the growing humanitarian crisis, was felt worldwide. Many members felt moved to support those affected and wrote to us.

Helpers worldwide organized simultaneous *latihans* to spiritually support our brothers and sisters in Ukraine and Russia.

WSA and SDIA issued a joint appeal for an emergency response fund for the Ukraine crisis. SDIA is designated by the WSA to take action in humanitarian crises where Subud members are ready to become involved in the response.

Over \$80,000 USD was raised and coordinated support efforts included the provision of medical supplies and equipment, food, clothing generators, and accommodation for refugees.

WSA Board of Directors meetings

There were ten Board of Directors meetings held in 2022. In addition to providing a forum for regular updates from the Zone Representatives on the condition and situation in their respective Zone, topics discussed included:

- Financial matters country pledges and WSA 2022 budget; reserves policy; grant disbursements to Zone 6 for internet connection; MSF 2022 budget amendments.
- Wings and affiliates establishing meeting programme with respective boards; charters with SICA and SDIA.

- World Congress preparation members survey; World Congress guidelines for delegates; congress dates; venue options; and WSA membership criteria.
- WSC meeting planning for an inperson WSC meeting in Kalimantan, February 2023.

Wings and affiliates

In line with the request of the Board of Directors at the beginning of the year, it was agreed to convene at least one meeting a year with the boards of all wings and affiliates to promote and maintain effective communication and relationships.

The WSA board members met with the boards of SDIA in March, SESI in May, and SICA in June. These productive meetings discussed wing activities, reaching out to members, increasing wings visibility, and ideas for World Congress. There were several follow up meetings with SDIA to discuss the development of a charter between the WSA and SDIA.

A joint meeting with MSF was held in November to agree amendments to the 2022 budget to facilitate the process of the Gran Salon sale.

WSA EXECUTIVE COMMITTEE REPORT

(Continued)

World Congress Organizing Team (WCOT)

As part of the preparation and planning for World Congress, the Executive Chair met with the WCOT in Kalimantan in April. Several meetings took place, including with the Subud groups in Palangka Raya and Rungan Sari, and with the authorities, including the city Mayor and police departments. While the local officials felt confident Indonesia's presidential elections scheduled for 2024 would not be a cause for concern or disruption, it was clear that careful advance planning is needed, including permits from the local and national government.

The WCOT prepared and issued a survey in June to understand likely world congress attendance and members' key priorities and concerns. The International Helpers also provided guidance for World Congress. Using this feedback, the WCOT prepared venue scenarios that were presented to the WSC in September.

Archives

The WSA Archives is among the most discussed topics in WSA meetings. The Executive Chair actively participates in most WSA archive meetings with the subcommittee members and the archivist. There are 18 to 24 archives meetings per annum.

Together with WSA Archive Subcommittee Chair and WSA Deputy Chair, the WSA Executive Chair visited Canberra, Australia, in March to oversee the digitization process of WSA archives materials and discuss the plans for the proposed new facility. In July, the Executive Chair and Archive Subcommittee chair visited the Subud USA archives facility in Amani, Washington, and discussed the living archive project.

White Book – Guidelines for the Subud Organization

The White Book Team meets monthly, and the Executive Committee participated in meetings in February, March, May, and August. Following guidance received from International Helpers, work began on further revisions to the draft. The Guidelines aim to be practical, light, and concise, and reflect Bapak's guidance and advice on the organization, tasks and responsibilities of role holders, and the relationships between helpers and committees.

Working Parties

To progress key objectives of the WSC, two working parties were formed of members of the International Helper *dewan*, Zone Representatives, and the Executive Committee, who met throughout the year to:

 Develop 'Delegate Guidelines for World Congress', including international officer election procedures, the process for submitting proposals for Congress resolution, and the roles and responsibilities of member delegations. The draft was issued to delegates for feedback in October, and the guidelines were finalized at the end of 2022, and published in January 2023.

 Harmonize relationships with the affiliates and wings and enhance mutual understanding between international Subud organizations. The focus of the working party was developing a memorandum of understanding / charter with SDIA, which continues to be worked on.

Other activities

The Executive Committee also participated in:

- Zonal and National Congresses, including the Zone 3 & 4 Gathering in Assisi and the Zone 8 meeting via Zoom
- The continued development of the new WSA website (launched in 2023), including obtaining and responding to feedback from the Council members.
- The preparation for the sale of the ex-BSB land in Wisma Subud, Cilandak, a property owned by Yayasan Subud and held on behalf of the WSA.
- Coordination of the WSA Care Support Program. In 2022, only one disbursement was made following testing from the Emergency Fund to a member in Colombia for economic hardship.

WSA ARCHIVES CANBERRA HISTORY & PROJECT MILESTONES

he need to establish a purpose-built archival facility to house the WSA Archive Canberra collections has been a high priority from the start of this Council's term (2018-2024).

It is the only Subud international archive center for which WSA has sole administrative, operational, and financial responsibility.

The Canberra archive has served as the principal repository for the founding and corporate records of the international entities of the Subud organization, including the WSA and its wings, affiliates, and major projects.

The collection generated by Harlinah's History of Subud project became very extensive over the years. The collections also include the WSA Film and Video archives, the WSA Sound Archives, and a WSA photographic collection of 20,000 images. Records at risk globally have also been sent to Canberra.

2005-2010

During the 2005-2010 ISC term, Canberra is designated as one of two main WSA Archives exclusively for international collections.

2018

The construction of a purpose-built facility was identified as a critical priority from the beginning of this Council's term.

2021

In October 2021, a second architectural plan was developed for a two-stage construction.

This was also too costly.

1993

Harlinah Longcroft Settles in Canberra, bringing with her the *History of Subud* collection.

Canberra becomes a major international locus of Subud archives.

2013

On completion of the Memnon project, the digital files of Bapak's talks were sent to Canberra, followed by the original analogue tape recordings of the talks.

The secure, climate-controlled studio of Artsound FM, a community-based radio station, is used to store the collection.

2020


■ The circumstances of Artsound change, and there are concerns about the safety of the film collection. It is moved to a rented commercial storage facility in mid 2020, however, there is no climate control, heightening the rate and risk of degradation.

Back-up copies of the LTO tapes are sent to the Cilandak archive for replication and distribution to the USA, UK, and Japan.

In September 2020, the first architectural plans for a new archive facility on the Subud Canberra site are developed.

The cost was beyond the resources of the WSA.

2022



This did not offer significant savings over local construction.

The concept plan of containers for the repositories was developed in December 2022. This evolved into three 12-metre insulated containers covered by a shed, with an office/archival workspace, with preliminary project costings of USD 482,043.

This plan was prepared for approval at the next WSC meeting in Kalimantan, February 2023 ...



Harlinah Longcroft passed away in December 2022.

Unbeknown to the team developing the concept plan, she had left a bequest of USD 140,514 (estimate) to MSF for WSA Archives Canberra.


OVERVIEW

For organizational purposes, the World Subud Association (WSA) is divided into nine zones.

o coordinate the work of the WSA, each zone has a representative who sits on the World Subud Council (WSC) to represent their countries and zone council between world congresses.

Each zone council is made up of four delegates from every member country in the zone - the chairperson, the committee councilor, and a male and female kejiwaan councilor. The zonal representative is chosen by the country delegates.

The work of the zone councils is important because the participation of each country delegate is necessary to ensure the democratic running of the WSA.

Membership overview

one 1 & 2 consists of 11 countries and some members in Iran. ■ While there is no unifying focus or activity other than being in the same geographical area, when there is communication amongst the Zone countries, there is a sense of a shared identity.

While COVID related restrictions have eased in almost all countries, many groups are now smaller, and some members continue to do latihan at home

Indonesia and Australia both have large and active memberships, including many youths in Indonesia, and in the Perth group in Australia.

Japan, Malaysia, and Vietnam are feeling the effects of an ageing membership, including the inability to meet easily for *latihan*, and filling helper and committee roles.

While Bangladesh, Singapore, Sri Lanka and Thailand have few members, these are long-standing and committed.

Communication and activities

The last Zone 1 & 2 meeting was held in December 2021; the next is planned for February 2023 in Kalimantan, and Subud Indonesia has been very supportive in facilitating this. Regular email communications are issued to all countries, including all official WSA communications.

Countries such as Australia, Japan and New Zealand have traditionally been active communicators in various Zone meetings and generally throughout the year. Other countries often communicate only in response to specific requests for information. Some countries communicate well when the need arises.

Some countries held in-person congresses and meetings throughout the year, including Japan and New Zealand. In Vietnam, some members gathered to celebrate Bapak's birthday. Australia held its meetings online; its first in-person Congress since the pandemic is planned for Perth in 2023.

The divisions in India continue, and the two 'national' bodies signify the ongoing disagreements about organization and governance. The WSA and International Helpers are supporting the efforts towards reuniting a single and lasting 'Subud India'.

While diverse, there is a shared sense of identity

when Zone 1 & 2 countries communicate.

Wings activities, enterprises and centerprises

There are Subud houses in most countries, with several generating income. In Australia, there is a properties fund that can support maintenance when needed, and the Sunshine Coast group has recently constructed a new latihan hall. The Christchurch group in New Zealand continues to examine the possibilities around the earthquake payout and future development opportunities.

Australia, Japan, and New Zealand are consistent donors to the WSA. Singapore and Sri Lanka contributions are generous given their size. In Indonesia and Australia there are enterprises that contribute to the WSA, and both have many members involved in a range of wing activities.

THE RUNGAN SARI FESTIVAL: **CELEBRATION & COLLABORATION**

s part of Bapak's birthday celebrations, the Rungan Sari Festival 2022 was held over the weekend of June 25 and 26. It was hosted at the Rungan Sari Resort.

The event was organized by the Rungan Sari Subud committee and Subud Youth in collaboration with the Rungan Sari Resort and other Subud projects and enterprises, Subud Palangka Raya, and Subud Indonesia, as well as the local community.

The organisers expressed the intention of the event as follows:

In commemoration of Yang Mulia Bapak Muhammad Subuh Sumohadiwijoyo's birthday, Rungan Sari Subud Committee intends to organize an event involving Subud members and the wider community around the area of Bukit Batu, Palangka Raya. This event is meant to strengthen our association and to prepare us as hosts for World

Congress 2024. This event is also meant to acknowledge and support enterprises run by Subud members and non-members to boost their business growth, and to inspire those who are wanting to pursue a business small and medium enterprises.

To present Subud to the city and surrounding communities, an exhibition of the history of Subud was organised by Ary Sutedja from Jakarta. This consisted of photos of Bapak and the history of Bapak's trip to Kalimantan, as well as photos of Subud and its development in Kalimantan. Helpers were present at the exhibition to give explanations and answer questions about Subud.

The Rungan Festival 2022 was an event open to the public in general, people from Palangka Raya and the surrounding areas of Rungan Sari attended. It was a great collaborative effort between Subud and non-Subud people, between well-established

enterprises, small businesses, local authorities and volunteers.

The main theme of the festival was entrepreneurship, focusing on micro, Anyone interested (from the city, surrounding communities, Subud and non-Subud) was invited to have a booth at the festival to display their crafts, sell their products, and so on. Existing Subud projects such as KSK, Borneo Escape, Kedai, BPI, YUM, Adhara Silver, BFIA, and BCU were among those who participated in the exhibitions and bazaar. There were special seminars, cultural presentations, dancing, singing, and video screenings, as well as sports.

Rusdi Bustillo noted that "For me, it was proof once again that when all Subud parties work together with a unique / unifying goal, we can be very successful at all levels and we can create something special to share with those around us."

Western Europe

The return of in-person gatherings, National Congresses, and International Helper visits across the Zone have been a catalyst to reunification.

Membership overview

hile some countries are taking longer to re-group after the pandemic, with some members still preferring to do *latihan* at home, the return of in-person gatherings, National Congresses, and International Helper visits have been a catalyst to reunification.

Portugal is in a positive state, as well as Belux (Belgium and Luxembourg), although with a much smaller membership. Ireland and Italy have scattered memberships, but numbers stay stable. France and the Netherlands have felt a lack of national togetherness. Spain remained steady with its strongly established local communities. Britain, having been through a turbulent period, is slowly seeing harmony restored.

What all countries have in common is difficulty in filling organizational positions. and we explored the possible causes and solutions, including how helpers and committees work together, throughout the year.

Communication and activities

A three-day Zone 3 delegate meeting was held in Lucca, Italy, in February, which was the first inperson zonal meeting since 2019. Each day was centered around a theme – introspection, activities in the Zone, and international matters – and included preparation for the joint Zone 3 and 4 gathering in Assisi in October / November (detailed overleaf).

Regular zonal Zoom meetings continued, and eight were held throughout the year. These were well attended, and usually each country was represented. A working party was formed to explore possible congress resolutions and met regularly.

The Zone 3 magazine, Project & Properties, continued to be published quarterly. Britain, France, and the Netherlands publish national newsletters.

Wings activities, enterprises and centerprises

There are formal representatives for some of the Wings in France, Portugal, Spain and the Netherlands. Britain continues to have the most active and complete Wings organization, and the national council is making efforts to collaborate more closely with the Wing representatives.

Subud Portugal made the final payment on its bank loan for the Lisbon Subud House, and work on the development of Bucelas continued. The Amaranthe eco-village project in France made further progress, including plans for a new Subud House. Property issues were a leading item on the Subud Britain national agenda, with teams of experts formed to support work associated with properties in Lewes and Loudwater. There are plans to sell the Hague Subud house in the Netherlands.

Zone 4 has a long history of active cooperation and solidarity between the countries. This togetherness was particularly evident from the outset of the Ukraine invasion in February, with countries actively supporting the Ukraine Aid team, organizing travel and accommodation for refugees from Subud families, and sending medical material and equipment, and generators. For several months there were weekly meetings with SDIA, SD-Nationals (the France, Netherlands, Norway), Country teams (Germany, Poland) and the Zone.

In all countries group *latihan* is done on regular basis, although the attendance has not yet returned to the pre-covid levels in some places.

Delegates meet monthly on zoom, discussing information from WSA and sharing about situation in the countries. Participation varies between 10 and 6 countries. Others communicate by email. The interest for international organizational issues tends to be moderate. The delegates are glad to be informed and express trust in the present WSA team.

The highlight of the year was the long awaited joint Zone3&4 gathering in Assisi (detailed overleaf). Thanks to the support received from GHFP foundation we could support members from Ukraine, Russia and Lebanon to attend, although visa issues prevented some from coming.

This year, work started on developing a chronology of events in Zone 4 (including Zone meetings, holiday camps, wings gatherings etc), as well as history of Subud in all the countries in the Zone. While some

countries, such as Germany, have been continuously collecting historical material, finding historical data has proved difficult in other countries, which shows the importance of not postponing this work further.

Wings activities, enterprises and centerprises

The Zone delegates have expressed the need for projects to unite and activate the members. Some countries (Austria, Greece) report about renting out / sharing of Subud houses – a soft beginning of centerprises, which is already bringing some positive financial effects.

Germany has a strong and active Susila Dharma organization, there are also SD organizations in Norway and Israel. SIHA is active in Germany. Members from Germany are also actively involved in a budding Subud enterprise, E-Lango, which provides language services including translation and copyediting.

TOGETHER IN ASSISI OCTOBER 26 - NOVEMBER 3

he long awaited joint Zone 3 & 4 gathering in Assisi, Italy, was fruitful, harmonious, and deeply fulfilling. This truly international event brought together over 350 participants from 36 countries, including many young people and families. Among the guests were WSA officers, including the WSA Chair and Executive Chair, and 12 International Helpers.

The plentiful *latihan* and *kejiwaan* was combined with delegate meetings, wings activities, varied workshops, and cultural entertainment.

Togetherness was a prevailing theme.

Zone 4 Representative Salama Gielge said, "The intensity of Assisi – both the spiritual dimension, the *latihan*, and the human connection, or reconnection experienced - took us by surprise... It was moving to see

our brothers and sisters from the war-stricken countries sitting together and translating for each other, to hear them share how afraid they were of this encounter – and how relieved to feel the love and mutual support unchanged. "

Zone 3 Representative Hannah de Roo remarked that "There came a strong feeling from within all the wings, and between members involved with wing activities, to work together more closely... An outcome of an intergenerational sharing circle, in which members of all ages participated, was to forget about the 'age gap' – it creates a separation that doesn't serve us, and there is no such thing when we relate to each other with sincere openness, and a willingness to cooperate."

Zones 3 and 4 held separate and joint council meetings, providing an

opportunity to share and learn about the situation and challenges in each country. World Congress guidelines and proposals were discussed, and open meetings with MSF, WSA officers, and the International Helpers provided opportunities to get a deeper insight into their work.

A presentation about the World Congress in Kalimantan by the WCOT Coordinator and WSA Executive Chair was very well attended, with the opportunity for members to ask questions. When asked who planned to attend, almost all audience members raised their hands.

A surprise outcome after the gathering was a surplus of nearly 10,000 € due to many donations. This was shared between Zones 3 and 4, and put towards a youth fund and supporting members in Ukraine



Membership overview

here are four member countries in Zone 5, as well as members in Algeria, Senegal, and Zambia.

Despite the pandemic, the membership in Malawi and South Africa has grown, with some older members coming back.

The pandemic dismantled a lot of things for the only member in Zimbabwe - surviving became a challenge and projects suffered. There was no communication or update from Nigeria in 2022.

There are four members in Zambia who are often travelling, but they meet for *latihan* together when possible. There are two members in Senegal who are unable to meet regularly but do simultaneous *latihan* together.

Members hope to attend the World Congress in Kalimantan but will need financial assistance to do so.

Communication and activities

Communication is challenging.
Contact has been lost with some countries; with others communication is limited or sporadic.

Newsletters and reports continue to be shared by email. Isolated members have expressed appreciation of these for keeping them connected to the Subud community.

South Africa is the most active and communicative member country and has a national organization. There are two main groups; the Cape Town group has started meeting regularly again, have well attended *kejiwaan* meetings and use WhatsApp to stay connected, but the Johannesburg group is struggling. Subud South Africa will have its next National Congress in March 2023.

The International Helpers were hoping to visit South Africa, Malawi and possibly Nigeria in 2022, but had to cancel. Their visit was then moved

to 2023, but now they hope to visit in 2024, just before the World Congress.

There are two groups in Malawi, who have regular *latihans* in rented premises. Many of their members tend to travel back and forth to the UK, as they have family there. Subud Malawi still does not have a national committee; they have been encouraged to start the process of forming one.

Members from Malawi and Zambia attended the Assisi gathering and felt the benefits of reconnecting with many Subud members.

Wings activities, enterprises and centerprises

South Africa is the only country with its own Subud houses. Both groups rent out their *latihan* space, which makes the properties less of a burden on the membership. It is also the only country to support the WSA with regular annual donations.

Communication between the Zone 6 countries, and with the WSA, is challenging.



Membership overview

here are challenges in terms of finances and communication in Zone 6, and conditions in the countries are difficult. There is a lack of experienced helpers and spaces for group *latihan*. The pandemic caused groups to disperse, and some are having difficulty in coming back together.

Since the passing of the contact person in Algeria, there has been no communication, which was previously maintained via the Zone 5 Representative.

Communication and activities

Communication is only via emails and phone calls. The WSA provided a grant to Zone 6 for internet connection.

Two members from Angola attended the Assisi gathering, including Emanuel Mbassi, the Zone 5 & 6 Youth Coordinator, who facilitated the sports programme.

Wing activities, enterprises and centerprises

The Democratic Republic of Congo is the only country that has its own Subud houses. It also has an active Susila Dharma (SD) national organization.

In 2022, SD Congo, in partnership with SD Canada and SDIA, began the implementation of an ambitious five-year project to create three Community Learning Centers for women and girls. SD Congo is also working with SD Germany to develop network of Health Mutual Associations, hospital and healthcare centers serving five communities in Kinshasa and Central Congo Provinces. The latest development was the Phase III extension of the Mother-Child Hospital Center, completed in December 2022.

In Angola, SDIA member project, RSD Guelson, supports the physical, mental, cultural development and the social inclusion of young people through sport, particularly football and handball.

Collaboration and mutual support is strong throughout Zone 7.

Membership overview

ubud activity across Zone 7 has included a great deal of electronic connections via Zoom meetings, chat groups, and call-in latihans. In-person participation at group *latihan* has increased and some social activity has resumed across the Zone.

There have been openings reported in several countries, including a wave of younger members in Mexico. Active efforts are being made in Canada to engage vounger members in roles. including a 'shadowing' committee initiative by the Toronto group.

Communication and activities

Zone council meetings were held quarterly, and in January the WSA Chair joined as a special guest. Important topics for the Zone in 2022 included financial sustainability for Subud, the wings' increased activities and connectedness, contact with members in the Caribbean, and youth engagement.

Subud Canada and USA publish regular national newsletters that have an international reach. They are collaborating in a joint bid to host the 17th World Congress and conducted a survey to gain members' opinions and input.

Subud USA is actively supporting the Archives, including monthly donations to the WSA by the national organization, and several media professionals have visited groups and gatherings to record Subud members' stories.

Wing activities, enterprises and centerprises

There are established Susila Dharma (SD) and SICA national organizations in Canada and the United States. In the Caribbean, the first SIHA meeting was held and attended by local officials and community members.

There was a strong response to humanitarian needs in Ukraine and elsewhere by the Zone, countries, SD nationals and individual members. This included emergency assistance funds and support for pensioners in selected areas.

Canada's four Subud houses all operate enterprises and are recovering from Covid related impacts. A national fund has supported repair and renovations works.

Subud Mexico continues its efforts to raise funds to buy a Subud house, and the Zone 7 council has offered its

Suriname has two Subud houses; one has been subject to two acts of theft and vandalism. A fundraising campaign for repairs was met with positive support, and the works were able to get underway.

Subud USA own 15 Subud houses and several generate income. The acquisition of the Amani-Twin Oaks property was completed in October.

Membership overview

roup *latihan* and in-person meetings have resumed in Costa Rica, Colombia, and Ecuador. In Venezuela, the ladies are generally continuing with simultaneous latihan at home. There are three isolated members in Panama who are supported by the International Helpers and participate in the Area 3 latihan.

Colombia has the largest membership in Zone 8, followed by Ecuador. There are two groups in Costa Rica, and in Venezuela, and while the membership is relatively small, it is very active, including participation in Zone meetings. There were openings in Colombia, Costa Rica, and Venezuela.

Communication and activities

Zone council meetings were held monthly, and an online Zone 8 meeting, open to all members, took place in September. There is a Zone 8 communications team, which includes members from Panama and Costa Rica, and a zone newsletter is regularly published.

In-person national congresses were held in Ecuador and Colombia and new committees, national helpers and Wings representatives were appointed. There was a threeday kejiwaan workshop in May for helpers from all over Colombia, and celebrated 60 years of Subud in Colombia in October.

Zone 8 fundraising enabled support to be provided to members financially affected by the pandemic in Venezuela, Colombia, and Ecuador. Funds were also raised for members in Ukraine.

Wings activities, enterprises and centerprises

Throughout 2022, there was an emergence of new member initiatives for business creation and initiatives to support Subud entrepreneurs. In Costa Rica, the three members of the San Mateo group con-tinue to run the Casa Sula education center.

There are national Susila Dharma organizations, and active projects, in Colombia and Ecuador. In 2022 the Fundación Amanecer appointed a new board of directors.

In Amanecer, Colombia, SDIA held its annual meeting in the month of July and also organized a Human Force Camp that involved workshops related to education and environmental conservation.

CELEBRATING 60 YEARS OF SUBUD IN COLOMBIA

Subud arrived in Colombia! With I joy and gratitude to the Almighty, a beautiful four-day agenda was developed by the Cali Subud group, with in-person and virtual participation of members from different cities in Colombia and other parts of the world. Cali is the city where Subud Colombia was legally registered.

The program for this commemoration included video screenings of Bapak's Talks, *latihan*, stories collected in the book, Stories of Subud in Colombia, spiritual experiences and remembrances of those first visits of Bapak to Colombia, shared in person and virtually by some Subud members.

Sharif Marcks, Zone 8 Archivist, in his book, Stories of Subud in Colombia, records that memorable beginning:

"On the sixth of October, one thousand nine hundred and sixty-two (1962), at 6 pm in the house of Don José Iglesias, a group of SUBUD sympathizers met to form a society ... Engineer John G. Sillem acted as president. The Subud

n October 2022 it was 60 years since brotherhood was founded in Cali and another meeting... Mr. Gerardo Carvajal Londoño, initiator of Subud in Colombia, was appointed Provisional Secretary of Subud in Colombia since a formal Subud committee had not been established in our country for the year 1962."

> Gerardo Carvajal L. narrates that in 1960, exploring the teachings of George Ivanovich Gurdjieff, he saw the word 'SUBUD' for the first time in a book by JG Bennett, About Subud.

"As the address of Coombe Springs, Coombe Lane West, Kingston-Upon-Thames was noted in the preface of the book, he wrote to JG Bennett on 25 May 1962 for some information. Bennett replied announcing that Pak Subuh was in Indonesia and would probably visit Latin America the following year."

It was also learned that the engineer John G. Sillem worked in Bogotá Colombia and could provide information about Subud. John Sillem and his wife Sietske were authorized by Bapak to give the first openings in Cali.

"On the 5. 6. 7 and 8 of October the election of the Committee was left for 1962 in the house of Mr. José Iglesias located at Calle 5 Norte # 1-42 (A.N) Centenario neighborhood and Mr. Heinz Hagemann's house at Carrera 9 Sur # 6-41 Barrio San Fernando, the first openings in Colombia took place... That year, a total of 73 people were opened to Subud: 52 men and 21 women."

> A year later in 1963, Bapak was invited to Colombia, and he visited Bogotá and Cali for the first time. Bapak gave six talks during his visits:

Bogotá: April 15 - 19, 1963

- 63 BOG 01: Talk to members
- 63 BOG 02: Talk to members

Cali: April 20 - 26, 1963

- 63 CLO 01: Bapak speaks to people interested in joining Subud
- 63 CLO 02: Talk to members
- 63 CLO 03: Bapak chooses helpers and committee members and then gives a talk
- 63 CLO 04: Bapak's farewell talk



Activities in Zone continue to normalize, which supported by active group helpers and committees, and the return of group *latihans*.

Membership overview

n all Zone 9 countries, group *latihans* have been re-established, and helpers and committees are active in all groups. The membership numbers have remained stable, and there have been some openings.

Of the member countries, Chile is the largest with 130 members.

Argentina and Brazil have similar sized memberships of around 30, and Peru is the smallest with 10 members. There are also isolated members in Uruguay and Paraguay.

Communication and activities

The Zone 9 council met virtually in February, April, September, and December 2022. WSA work, news and world congress progress was shared with the council. In these meetings, information and activities of the countries were shared, and any queries are resolved. The Zone council is responsible for sharing this information, and WSA news, with the members via e-mail.

In November, the International Helpers visited Chile, which was well attended by members and young people. The Zone 9 representative also attended with financial support from the WSA and shared with members about the progress of world congress, and the need to have a face-to-face Zone meeting to elect the next representative.

In December the Zone decided an in-person meeting in 2023, and Perú and Chile were nominated to host the meeting. Testing showed difficulties in Peru (the political crisis and social unrest unfolded shortly afterwards) and greater fluency in Chile, where it was decided to hold the meeting at the end of April 2023.

Wings activities, enterprises and centerprises

Since the pandemic there have been no organized SICA, SDIA or youth activities, but it is hoped this will be reactivated soon.



Zone, some of which have developed enterprises.

In Peru and Brazil, space in their Subud houses continue to be rented as Airbnb, and with this income the needs of the groups are taken care of.

To maintain the Subud house in Mina Clavero, Subud Argentina rents out a bungalow long term. The Buenos Aires house is supported by membership dues, but this is not enough.

The Subud houses in Chile are supported by the money from the membership dues and this is enough. It is not possible to rent space due to tax issues.


he main aims of the Subud organization are to facilitate the practice of the *latihan* and help members to understand its benefits and how to apply it in their everyday lives.

To further these aims, 18 helpers with an international function are selected by testing for a term that lasts between world congresses.

The International Helpers work in three geographic areas and serve the members across the zones as shown in the map below.

Helpers in the Zones

- Local helpers serve the members of their Subud group and support the group committee.
- Regional helpers are appointed in countries where multiple groups are organized into regions and serve all the members in the region and support the regional council.
- National helpers, including kejiwaan councilors, serve all members and support the national council. Kejiwaan councilors also support the zone council.

The full International Helper dewan met in Porto, Portugal, from June 13th to 26th in the comfort of Isti and Hamid da Silva's apartments. Our gathering was truly harmonious, marked by latihans that somehow enabled us to work in a quiet, connected way that felt satisfying, moving us into a good place to work together. WSA Chair Nahum Harlap and Zone 3 Representative Hannah de Roo also joined us for part of the time.

We spent time talking and testing about the upcoming World Congress in 2024. Testing made clear that the content of the congress must be the *kejiwaan*, and that the location in Kalimantan was meant to highlight Bapak's guidance about the development of a true Subud culture,

as if the congress itself were a kind of petri dish in which our culture could develop and grow.

We also held a worldwide Zoom session with at least 250 helpers from many countries, discussing several topics, answering and testing questions and making connections. The comments later were overwhelmingly positive, and another such session is planned for a future time. It was clear that the isolation imposed by the pandemic has had an effect on us all, and that as conditions improve, it was important to go "back to basics", doing latihan twice a week, have regular helper/ committee latihans, and ensure that the organizational structures in place conform to Bapak's guidance.

Other topics discussed included the Archives, the SDIA-WSA relationship and the White Book. We also met virtually with the World Congress Organizing Team, relaying our collective receiving about the importance of the congress content and our feelings about Kalimantan.

The dewan took time to examine ourselves as well, testing how we are performing our roles and our attitudes. The harmony that grew between each of us was both gratifying and profound, and we all came away from the meeting feeling that something special had happened within us.

After the meeting, we went to Bucelas to do *latihan*, and we also shared lunch with the Lisbon group.



hroughout 2022, our Area 3 dewan maintained an ongoing program of Zoom meetings and simultaneous latihan. We also maintained a relationship of support and partnership with all national dewans in Area 3.

4 MUHAMMAD SUBUH FOUNDATION (MSF)

MSF is a vehicle for holding and maintaining Subud assets and for receiving donations and bequests from members and enterprises for Subud's long-term stability and security. MSF focuses on supporting Subud groups around the world to own latihan premises, so that members can worship God freely. In addition, MSF supports international helpers' travel to groups, to ensure that groups follow the latihan in the right way. And, if it has the means, it supports the Wings.

Mission and purpose

he mission of the Foundation is to foster the worldwide growth and long-term development of Subud through the *latihan kejiwaan* as our founder, Muhammad Subuh Sumohadiwidjojo, originally received it.

In 2015, the Foundation, following the guidance from Ibu Rahayu, sought to achieve its mission by directing its resources towards three objectives:

- Supporting Subud groups in the purchase and improvement of their Subud properties.
- 2. Supporting the travel of our international helpers to work with local and regional helpers in countries around the world.
- 3. Providing funds that help preserve Bapak and Ibu's material relating to the development of Subud.

Funds permitting, MSF supports affiliates (called Wings) recognized by the WSA that promote cultural, educational, social, and humanitarian work for the human community.

MSF is a 501(c)3 nonprofit corporation registered in the Commonwealth of Virginia, USA.

Activities

The Foundation awarded grants totaling nearly USD 105,000 - USD 47,500 for the purchase or capital improvement of Subud Houses, and USD 57,111 for the World Subud Association (WSA).

The WSA grant supports the travel of International Helpers, the WSA Archives (archive storage fees, digitization work, and Preservica digital preservation cloud platform), and the distribution of Bapak and Ibu Rahayu's Talks by Subud Publications International (SPI).

One of the major milestones of the year was the successful sale of the Gran Salon in Amanecer, Colombia to the Guerrand Hermes Foundation for Peace (GHFP) for USD 240,000.

Also, the bylaws sub-committee, led by Lucian Parshall (Trustee), successfully conducted the process of renewing the MSF bylaws, with great support from the WSA and the MSF team.

Financial report

This 10-year average investment growth was revised in 2022 to 4.75% per annum and is anticipated to be the average annual growth over the coming 10 years. This is constantly being monitored by the Investment sub-committee and MSF's portfolio advisor.

The Endowment fund set up by WSA within MSF stood at the year's end at USD 84,987, and no grants will be made from this Endowment until the principal reaches USD 500,000. MSF received two legacies in 2022 and funds from the sale of the Gran Salon.

Susila Dharma International Association (SDIA), and Subud International Cultural Association (SICA), are Affiliates, and are legally registered and financially independent organizations.

Subud International Health Association (SIHA) is an association of Subud professionals.

Subud Publications International (SPI) is an independently registered organization providing publication services to the WSA and its members

Subud Enterprise Services International (SESI) and Subud Youth Activities International (SYAI) are subcommittees of the WSA Executive Committee.

The WSA Executive Committee is also responsible for and coordinate other services and programs, including WSA Archives, Translations and Care Support.

SDIA works globally for just and sustainable development and contributes to Subud's aims by supporting members' work and initiatives.

SDIA Chair: Vincent Mount

Aims and objectives

DIA works globally for just and sustainable development by:

- Empowering individuals and communities to engage in positive human, social, environmental, and economic change
- Creating partnerships to achieve grassroot participatory initiatives

SDIA acts as a supporting coordination organization for all associate member projects and 21 national Susila Dharma organizations, who are our voting members. In 2022, SDIA had 31 Associate Member projects and three SD Nationals in the process of implementing projects.

SDIA's role is to enable Subud members who feel guided from within to take action in the world to get started with social and humanitarian projects that become established in their local communities. We support these projects to grow and flourish, as well as coordinating the aims and intentions of Subud members involved

in raising funds and managing their national Susila Dharma bodies.

WSA and SDIA have a long-standing agreement that SDIA is tasked with providing leadership on humanitarian appeals within the Subud community.

Activities

We continue to support a diverse range of inspirational development projects around the world, with the emphasis on small-scale works in the agricultural, environmental, health, social welfare, and educational fields. Each is unique and reflects the diversity and individuality of the Subud members involved, and the specific contexts in which they are set.

In 2022, SDIA spent \$65,187 to deliver services and technical support to its members and distributed \$374,065 in grants to projects. SD Nationals also provide grants directly to projects and most of these do not go through SDIA, so the total footprint of the SD Network worldwide can be valued in the millions of USD. To provide a source of stable funding, SDIA maintains an Endowment Fund, valued at \$1,052,343 at the end of 2022.

A joint fundraising campaign with the WSA was initiated in response to the Ukraine crisis. Over \$80,000 USD was

our national Susila Dharma chapters and the WSA were guided by Matviy Maslov, Subud Ukraine Chairman, and Subud members in neighboring countries, to identify priorities and help get materials and support to where they were needed most.

Our first in-person Annual General Meeting in three years was held in July in Amanecer, Colombia. This was chaired by Evan Padilla, who passed away shortly afterwards. At an Extraordinary General Meeting in November, the SD National voting members approved Vincent Mount as Chair to serve until the World Congress in 2024, which was Evan's remaining term.

Challenges

Difficult financial situations faced several of the SD projects worldwide. We assisted them with coordinating funding support and giving advice where necessary. This included:

• Collaboration with an Enterprise Support Group formed of Colombian Subud members and WSA Vice-Chair Rosario Moir to find a way forward for Mis Corazones Alegres (My Happy Hearts), a home for elderly people with dementia near Medellin in Colombia.

- Capacity building funding and help in raising bridging fund support for the FUEGOS (Food for Social Change) project in Ecuador to enable this project to continue helping train young people from the local area to develop food-based
- Working with I Protect Me (IPM) in South Africa to coordinate funding support, with the aim that they can be more self-sustaining in the future, attracting funding from external partners and businesses in the country.
- Helping raise match funding support to meet the shortfall of construction costs for the new indoor training hall at Borneo Football International Foundation (BFIF) in Kalimantan.

Collaboration

Two successful Human Force Camps were held in 2022 - in Amanecer. Colombia, and Atlanta, Colorado. This has inspired the development of Youth Engagement strategy and formation of a support group, with the aim of capturing young Subud members' aspirations to work in the humanitarian field and involve them in the SD network.

SDIA's Environmental Action Planning group, led by Subud youth, continued to work to support all SDIA members to develop their own action plans that will allow them to be conscious of their environmental footprints and take measures to reduce their impact. SD projects are working to reduce the presence of toxins, pesticides, and greenhouse gas emissions through promotion of organic agriculture, permaculture and the use of alternative energy sources.

Together with the Subud Education Association, SD projects are working hard to make sure that their communities have access to health and education services which are essential for improving lives and livelihoods of current and future generations.

We provide information, training, networking, and support services as well as opportunities to engage and collaborate with cultural initiatives and events around the world.

Our key objectives for 2022 included:

- Working with the International Helpers to support members to become aware of their talents.

SICA helped facilitate the cultural program at the joint Zone 3 & 4 gathering in Assisi, which included musical concerts and a 'Peace One Day' evening. We also held our Annual General Meeting there.

Regular Conversation Café's have been held online, with topics including human culture and death. For the

Objectives

SA Archives is a service of and reports to the WSA Executive Committee.

The mission of the WSA Archives is to collect, manage, and preserve for posterity:

- The work of Bapak Muhammad Subud Sumohadiwidojojo, the founder of Subud, in its original form together with the evidential and contextual basis for that work.
- The work of Ibu Siti Rahayu
 Wiryohudoyo in its original form
 together with the evidential and
 contextual basis for that work.
- Those records giving evidence to the historical development of Subud and as normally archived by an organization of global significance.

Organization

The WSA has five international Archive Centers:

Cilandak, Indonesia: This center, located in Wisma Subud, is administered and funded by Yayasan Muhammad Subuh (YMS). The primary collections are the talks, letters, and writings of Bapak and of Ibu Siti Rahavu.

Canberra, Australia: Funded by the WSA, this center's collections are focused on the history of the development and spread of Subud, and the key organizational documents of the WSA and its Wings and Affiliates. It is also the location of the digital files of Bapak's talks from the Memnon Project and the accompanying original audio tapes from the WSA Tape Preservation Unit.

USA and Britain: These centers hold the national archives of their countries along with important international records.

Japan, along with each of the other WSA Archive Centers, holds a set of the early back-up archival materials distributed in 1979 and the microfilm distributed in 1993.

WSA ARCHIVES

(Continued)

We have embarked on a WSA Living Archives project to digitize assets of archival value and membership interest, beginning with pilot projects in Canberra and Subud USA of selected documentary, photographic, audio, audio-visual records.

Achievements

Canberra purpose-built facility

Two architectural plans for a purposebuilt archival facility for WSA Archives Canberra have been submitted to WSC since the beginning of this term, but both were deemed to be beyond the financial resources of WSA.

Modular building approaches were then investigated in the 2022 mid-year, and costs were found comparable to local construction.

In December a concept plan for the use of containers as repositories was developed with the goal of refining this and obtaining preliminary costings in consultation with prospective contractors, for presentation to the meeting of the World Subud Council in February 2023.

WSA Living Archives project

The WSA Archives Subcommittee have embarked on a WSA Living Archives project to digitize and provide managed access to assets of archival value and membership interest, beginning with pilot projects in Canberra and Subud USA of selected documentary, photographic, audio, audio-visual records.

We acquired the license to a cloudbased digital preservation platform, Preservica, and during the course of 2022 we recruited a digital archives team of five to manage the various elements involved in this venture.

Ultimately, we envisage digitizing significant records from each of the major international archive centers, the national collections of member countries, and the archival and operating records of the WSA and its entities and affiliates.

Amani Center

The move last year of the national and international archival collections of Subud USA to a climate controlled archival facility in the Amani Center, Subud Washington DC involved a major commitment of energy and time of the National Committee of Subud USA and many members, along with substantial financial contributions. This has stimulated a great deal of activity and interest in archives.

The Subud USA International Archives Board acquired an ownership stake in the Amani Center and purchased the neighboring land and building, Twin Oaks, for the conduct of revenue generating events and for the use of visiting archivists.

Daniela Moneta moved there to continue her work as a WSA archivist and to assist with the establishment and organization of the archives in this new setting, accompanied by her son, Howard Moneta, who took on the role of events manager. Daniela and Howard initially anticipated staying for a year.

Objectives

he objectives of SPI are to implement and manage the Bapak's Talks Translation Project on behalf of WSA (the license and copyright holder), and to produce new English translations of Bapak's recorded talks for dissemination in various formats to Subud members.

Activities

The activities of the project team consist of transcribing and translating Bapak's recorded talks to the highest possible standard for dissemination to Subud members.

Achievements

English editions

Sales of Volumes 1 to 39 in 2022 amounted to 350 copies (including subscriber copies). Complimentary copies were also provided to the International Helpers, the Archives and the Project team.

Bapak's Talks Volume 38: This edition, completed in 2021, was published on 10 January 2022.

SUBUD PUBLICATIONS INTERNATIONAL (SPI)

Subud Publications International (SPI) is an independent charity, registered in the UK, and run by Subud members. *Bapak's Talks* editions are available at: www.subudbooks.com



Bapak's Talks Volume 39:

Translations were completed in 2021 for editing and final proofreading to take place during the period. This edition was completed and available on 1 October 2022.

Bapak's Talks Volume 40:

Translations, provided during 2016/2018, were checked against the Memnon copies as required. Proof reading and checking was completed and submitted to the translators at the end of November for their final checking. It is planned to go to print in early 2023.

Bapak's Talks Volume 41: The 18 translations, provided in 2016/2018, were checked against the Memnon copies. Seven of these translations were provided for SPI processing during the period. The balance of translations to be provided for this edition are to be completed by end-2023.

Bapak's Talks Volume 42: The translations, provided in 2016/2018, were checked against the Memnon copies. The editing, checking and pre-press activities for this edition are estimated to be completed by end-2023. This edition concludes the World Tour, with Bapak returning to Indonesia to give 44 talks during the

period 1972 and 1976 – to be covered in future editions.

Bapak's Talks Volume 1 – Revision:

The current edition was published in 1993 and does not include the Indonesian transcription. Activities have commenced to review this edition to include the Indonesian and English translations checked against the Memnon copies of the recordings. This work takes place in the background as time permits.

Susila Budhi Dharma – pocket edition: During the period SPI initiated the project to provide an English only edition, incorporating the 2001 translation. To be available 2023/2024.

Spanish editions

The Spanish translation team completed *Charlas de Bapak Volumen* 30 in 2021 and forwarded it to SPI for print. This edition was available on 11 March 2022.

Challenges

We endeavor to increase the number of editions produced each year. However, attention to detail at all stages is a time-consuming process, whereby we have to balance quality with quantity, to maintain the highest standard.

TRANSLATIONS

To deeply understand the work of translations, all of us who work on it – WSA Archives, transcribers, translators, proofreaders, publishers, SPI, Subud Library, and national committees – recognize that: Bapak's and Ibu's words contain guidance and wise counsel for those of us practicing the latihan kejiwaan of Subud and deserve all the respect and care we can give so that, neither now nor in the future, the message be misrepresented.

Objectives

he Translations Subcommittee ensures that translations and translators follow all the instructions and requirements set out in the 'Manual for Translators and Translations'. This makes certain that:

- The source of translation is the proper one – Subud Archives or SPI
- Translators are properly appointed and have proof-readers
- Translations are sent to Archives

Activities

We held periodical Zoom Translators Workshops throughout the year, which are recorded and kept in Archives. Notes of the meeting are distributed among the translators and are available in the 'Translators Toolkit'.

Achievements

During 2022, we subtitled the following slide-video talks:

- 68 TJK 5 Indonesian/English/ Spanish/French
- 70 ROM 1 Indonesian/English/ Spanish/French/Italian
- 70 SKY 11 Indonesian/English/ Spanish/French
- 68 PER 1 Indonesian/English/ Spanish/French/ Russian

We also subtitled the following video talk:

 81 LAX 5 Indonesian/English/ Spanish/French

All videos are available on the <u>Subud</u> <u>Library</u> in their respective languages.

The Advice and Guidance for Bapak's Helpers (2018 version) is available in English, Spanish, French, Portuguese on the Subud Library. This year, the translation into Hebrew and print version was completed, and will be made available online soon.

Together with SPI, Ibu's Office and WSA Archives, we are working on easily identifying 'what Bapak said' from 'what someone says that Bapak says'. This is being developed into a guidance document - *The types of sources of Bapak's words*.

A big thank you to all the translators, proof-readers, editors, archivists that work quietly every day with the talks.



which the easing of the global pandemic, this year gratefully felt more like normal, with WSA finances showing a modest uptick in the amount of revenue received of USD 59k as compared to that in 2021.

The International Helpers were able to start traveling more extensively, and program activity perked up. As a result, expenditures rose by USD 23k over the previous year.

The WSA board of directors approved the opening of investment accounts in Fidelity for USD and other currencies. This gives us a wider range of conservative investment options such as treasury bills and commercial deposits. Through our Fidelity investments we were able to add USD 6,346 to our income for the year. Our other accounts netted us USD 60 in interest earnings.

Not included in the accounts are in-kind donations provided to WSA as officers go about their activities for the association. This year in-kind donations totaled some USD 11,308.

It should be noted that Cash Flows from Operating Activities improved over our 2021 position (USD -17,176), ending with a positive cash inflow of USD 20,064. This is due to receiving grants in 2022 from the Muhammad Subuh Foundation in support of international helper travel, archives,

and dissemination of Bapak's talks, totalling USD 60,100. In 2021, WSA did not request any grants from MSF in consideration of the uncertain global economy.



The WSA Endowment Fund

In 2022, the WSA transferred the sum of USD 9,855 to the WSA Endowment Fund held and managed by the Muhammad Subuh Foundation. This transfer to MSF is booked as an expense.

The Endowment Fund investments had a bit of a rough year in 2022 due to fluctuations in the global markets. The year began with a total value for the Endowment Fund at USD 88,525. Year-end total value for the Fund was at USD 81,164.

GLOSSARY:

Preserved Value (PV): Long term value of the endowment adjusted annually by the rate of inflation.

Total Value: Long term value plus/less the distributable value.

Gain/Loss from investments: Change in the value of the endowment's investment portfolio over a period of a year. MSF invests in a diversified portfolio of assets, such as stocks, bonds, with the goal of generating long-term growth and income.

Donations: Gift of money or assets that is received by MSF.

Admin Fee: Fee discounted from the endowment to cover the costs of administering and managing the endowment.

It is our hope that this Fund will increase in value over time. Your donations and bequests are much appreciated and will turn our hope into reality. Ultimately, the Fund will be able to contribute annually to the WSA budget to enable the continuation of important work such as preserving Bapak's talks and archives, and enabling translations, international helper travel, and the copyrights and trademarks protection.

Opinion

In preparing the financial statements, the management are responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the management either intend to liquidate the Association or to cease operations, or have no realistic alternative but to do so.

Those charged with governance are also responsible for overseeing the Association's financial reporting process.
