It organizes gatherings, disseminates talks by Bapak and Ibu Siti Rahayu, supports the acquisition of Subud premises, helper visits, publications, web sites, and access to and support for networks of Subud members.

2023 has been a year that saw a lot of work done.

The year started with the first WSC meeting in person since 2019, and took place in Rungan Sari, allowing your Council to have a close look at the facilities available for the World Congress.

The organization of the World Congress was a major topic for the year; concerns about the likelihood of getting a license to convene it just before the Indonesian elections led to a decision to postpone the World Congress. It took most of the year for the WSA Executive (ISC) to feel comfortable enough in their progress with the authorities to finalize the date.

The World Congress Organizing
Team (WCOT) has done a great job
of devising a schedule balancing the
needs of the participants, and the
Council made its decision in midOctober to approve the preliminary
schedule and how we would use of
both Palangka Raya and Rungan Sari
at the World Congress.

Another huge achievement was finalizing the plans for the permanent archives facility in Canberra, Australia, securing financing for the project and the building permits. The facility is being built now, and we hope it is complete before the World Congress.

We have also updated the Bylaws of the Muhammad Subuh Foundation (MSF), which, like the archives facility, was a task that required a lot of time to complete. In that, the curse of COVID became a blessing, giving us the additional time needed to be able to do what otherwise is hard to achieve in four years.

There are still a few minor loose ends that we hope to complete before the World Congress, and we hope to be in a position to pass to our successors a clean table.

Looking forward to seeing you all at the World Congress. To those of you who are unable to get to the World Congress and who, therefore, I shall not be able to thank in person: I would like to use this opportunity to thank you for trusting me with the role of WSA Chair - it has been an unbelievable blessing and an amazing opportunity to grow and develop.

Elwyn Waugh, WSA Accountant The WSA Executive Committee works closely with and supports the work of the World Subud Council (WSC), which is comprised of the WSA Chair, Zone Representatives (Board of Directors), International Helpers, and the Chairs of MSF, SDIA and SICA.

The Committee is responsible for the administration and day-to-day management of the organization, including finances, and manages and coordinates a range of services for the benefit of members, such as Translations, ICT and the WSA Care Support Program. The Committee also facilitates and oversees various working parties and sub-committees and is responsible for arranging the next World Congress in coordination with the World Congress Organizing Team (WCOT).

WSC meeting, Rungan Sari, Kalimantan, February 2023

2023 HIGHLIGHTS

WSC meeting, Rungan Sari, Kalimantan, February 6-14

he 2023 WSC meeting was the first in-person WSC meeting since the 2019 meeting in Cilandak, Jakarta. In attendance were:

- 15 International Helpers
- Seven (out of eight) Zone Representatives
- Three MSF Trustees
- Three SDIA board Members and the Executive Director
- SICA Chair
- One of the SESI Co-Chairs
- SIHA International Coordinator and one SIHA representative

- One SYAI Representative and four SYAI members
- Five WSA team members
- Observers from Australia, Germany, Indonesia, Spain and New Zealand

Meetings and *kejiwaan* sessions took place at the Muhammad Subuh Center and lasted for nine days.

The meeting agenda and topics discussed were mostly focused on strengthening relationships across the international Subud organization, and involved *kejiwaan* sessions with *latihan*, testing and sharing among the council members.

One key topic that was discussed extensively was the 2024 World Congress including logistics and the content of the congress.

The key outcomes of the WSC meetings and *kejiwaan* sessions were:

- Strengthening the relationship between the international Subud organizations, and between the organization and the members, by enhancing communications, information sharing, working together on projects, and working towards a more harmonious relationship.
- Awareness of the growth of the membership and regeneration of committees in Subud around the world.
- World congress discussions with Subud Rungan Sari, Subud Palangka Raya, and the Wings, and creating a program for 'one congress' (and not competing congresses).

WSC periodical meetings

Two WSC meetings were held in July and October via Zoom, and attended by the full council including International Helpers, Zone Representatives, international Subud organizations and WSA subcommittee representatives. The sessions were broadcast live via YouTube for members to observe.

The meeting in July was held over two days. The first day was dedicated to reporting by the council members. The second day was focused on World Congress. The International Helpers proposed questions for testing at the start of the meeting about the purpose of World Congress.

The meeting discussed proposals received to date by member countries, and the World Congress Organizing Team (WCOT) provided an update on its activities related to congress facilities and logistics, and the challenges associated with obtaining regional and national permits for a large international gathering during an election year. After discussion and assessment of the conditions and options, the WSC decided that the World Congress will not take place in January 2024. It was agreed to review the situation following advice from the WCOT on the permit situation in October.

In advance of the October WSC meeting, the WCOT prepared a range of scenarios for the congress program and venue, which included different options for the number of days to be spent in Palangka Raya and Rungan Sari. The Zone Representatives consulted with their member countries in advance and presented their feedback at the meeting. Following discussion, consensus was reached by council members for the congress planning to be based on seven days in Palangka Raya, and four days in Rungan Sari. The WCOT confirmed that July 2024 was viable for the World Congress, and that preparations were underway on that basis.

WSA Board of Directors meetings

The Board of Directors met via Zoom in January, March, September, November and December. Key topics discussed included:

- World Congress dates, member proposals, program
- MSF bylaws amendment and trustee selection process
- WSA Archives Canberra project fundraising and progress
- Financials approval of 2022 accounts and 2023/24 budget
- Ex-BSB land sale, Wisma Subud Cilandak

Coordination with MSF

The WSA and MSF formed:

- · A joint team for the selection of new MSF Trustees.
- A joint working party to draft the MOU between the two organizations.

WSA Archives

Following the WSC's approval of the concept plan for the purposebuilt archive facility in Canberra at the WSC meeting in Rungan Sari, the WSA Executive, supported by the WSA Archives sub-committee led fundraising activities for the remaining 30% of the funds required for the project. This was successfully achieved by year end through

donations by individual Subud members as well as Subud groups, national organizations and Zones.

History of Subud project

Following the passing of Harlinah Longcroft in 2022, a new team was assembled to carry on with the important work started by Halinah in 1983. The new WSA History of Subud team consists of Amalijah Thompson, Ridwan Lowther, Sandra Creemers and Rashidah Pope. They are working on revising, adapting, and publishing Volumes 1, 2 and 3 by July 2024, if not before.

After this aspect of the project is complete, a shorter "Concise History of Subud" covering 1901 – 2024 will be written and available to the public.

White Book - Guidelines for the Subud Organization

The White Book team have continued to refine the current draft, which was reviewed and commented on by Council members over the course of the year. Bapak's and Ibu's quotes were re-checked and the Spanish translation was completed in readiness for further review and comment. The team will prepare the final draft for presentation to Congress in 2024.

Other activities

The Executive Committee's activities also included:

• Supporting the preparation of the construction phase contractual agreement between WSA and

Subud Canberra. The agreement was signed by both parties on 6 April 2023.

- · Preparation for the sale of the ex-BSB land in Wisma Subud, Cilandak, a property owned by Yayasan Subud and held on behalf of the WSA. Land plots were offered for sale to Subud members in December.
- Coordination of the WSA Care Support Program: the WSC agreed that the emergency funds available through the Program is to be based solely on member donations, with an annual fundraiser undertaken in cooperation with SDIA. In 2023, approximately USD 12,000 was raised. A total of USD 3,373 was spent, covering emergency funds for Zone 6 and Zone 8 Subud members
- The WSA Executive Chair and WSA Treasurer both attended the Subud Indonesia National Congress in Surabaya in February 2023.
- The WSA Executive Chair attended the Subud USA National Congress in September 2023, and presented an update on World Congress, and participated in the global Subud Archive meeting held at the Amani Center
- The WSA Executive Committee organized a listening call with Subud Spain, Subud Australia, and Subud Britain, on their World Congress proposals relating to WSA bylaws changes.

PREPARING FOR WORLD CONGRESS A COLLABORATIVE ENDEAVOR





he preparation for the World Congress in Kalimantan has certainly faced unprecedented challenges – first, a global pandemic, and then the complications of organizing an international gathering during an election year.

So, we were delighted to be able to announce in October the congress dates in July 2024.

During the year, we cooperated closely with the local government and local and regional police to complete site risk assessments and surveys as part of the safety and security assessments required for international event permits, and feedback received was positive.

The WSA Executive and WCOT regularly visited Palangka Raya and held sharing sessions with local Subud Sari (our Subud development). members in Central Kalimantan. These sessions aim to inclusively involve all aspects and layers of Subud members in Indonesia, ensuring they stay informed about the progress and development of the World Congress organization. Simultaneously, the sessions gathered local feedback to determine what arrangements are ideal and suitable for the event locally.

The WCOT and WSA Executive also worked closely with the WSC to define the best way to host the World Congress in Kalimantan.

After many discussions, meetings, and kejiwaan sessions, with the aim of being as inclusive and democratic as possible, we agreed on a combination circumstances.


OVERVIEW

For organizational purposes, the World Subud Association (WSA) is divided into nine zones.

o coordinate the work of the WSA, each zone has a representative who sits on the World Subud Council (WSC) to represent their countries and zone council between world congresses.

Each zone council is made up of four delegates from every member country in the zone - the chairperson, the committee councilor, and a male and female kejiwaan councilor. The zonal representative is chosen by the country delegates.

The work of the zone councils is important because the participation of each country delegate is necessary to ensure the democratic running of the WSA.

Membership overview

one 1 & 2 is a diverse group of countries spread throughout Asia and Australia / New Zealand.

Australia, Japan, and New Zealand have well established national organizations, with Indonesia having the largest membership and many active youths. Smaller countries such as Malaysia, Sri Lanka and Vietnam have a dedicated membership. Thailand and Singapore are now very small groups. Despite the best efforts of the WSA and International Helpers, India has now divided into two separate organizations, with neither group representing Subud India.

While there is a great diversity of cultures, membership activity and issues, all countries have a sense of shared identity and awareness as members of Zone 1 & 2.

Communication and activities

Subud Australia had its first in-person National Congress since Covid, which was held in Perth in January. There were 160 attendees including International Helpers and other guests. A new National Chair and other office holders were appointed. Indonesia had its National Congress in Surabaya in February, which was well Zone 1 & 2 members have a sense of shared identity although there is a great diversity of cultures, membership activity and issues across the countries.

attended. Japan also had its first inperson National Congress since Covid in May at Subud Japan's Sakado center, near Tokyo. The members in Vietnam gathered for the Vietnamese Lunar New Year celebration.

The main event for 2023 was the Zone 1 & 2 meeting held at Rungan Sari on 18 February, just after the conclusion of the WSC meeting. While the meeting was small, country delegates from Australia, Indonesia and New Zealand attended in person, and delegates from India and Japan also observed via Zoom. This was the first in-person Zone meeting after Covid, and the main result was simply a chance to reconnect in person. Also in attendance were the Area 1 International Helpers, some WSA team members, and representatives from the Wings and MSF, who all gave presentations.

Aside from these meetings, contact was maintained via emails and WhatsApp. English is generally the

main language of communication and there are members who can translate if necessary.

Wings activities, enterprises and centerprises

Subud properties in Australia and New Zealand are rented out to provide income. Within New Zealand a notable example is the Auckland group, and the Christchurch group has increased activity in renting out its *latihan* halls. Christchurch also finalized plans to rebuild a new Subud House, which will better suit the needs of the group including possible rental activity for functions.

The main country donors to the WSA are Australia, New Zealand, and Japan. Within Indonesia, the Sekolah Cita Buana school in Jakarta makes a significant annual enterprise donation. Sri Lanka is generous considering its small size. There is a range of wings activity involving many members in Australia and Indonesia in particular.

SUBUD INDONESIA'S 30TH NATIONAL CONGRESS

Subud Indonesia held its 30th National Congress in Surabaya, February 3-5 2023 after being delayed for two years due the Covid-19 pandemic.

It was attended by almost 600 members, an unexpected number of participants. Besides Indonesian members, also present was the WSA Chair, WSC officers, International Helpers, and Subud members from abroad as observers. Local government and ministry representatives were present for the opening ceremony.

The opening ceremony started with a dance, 'Joged Suroboyo' (Surabaya dance). which reflected the happiness and harmony among Surabaya people although they have different backgrounds. This also represented the Congress theme, 'Build the brotherhood for the development of the nation'.

The event followed with the 76th Subud Indonesia anniversary celebration with a yellow rice mountain - the *tumpeng*. It was brought to the ballroom by four young people as is Javanese custom. Ibu Ismana and Ibu Yati represented Bapak's family and cut the *tumpeng*.

During the congress, there was a photo exhibition of Bapak Subuh's journey. M. Ridwan was elected as the Subud Indonesian chairman for the fifth consecutive term, and delegates agreed the next Congress location as Semarang, Central Java.

Western Europe

Membership overview

hile Britain, Ireland, France, and Italy continued with their standing representatives, BeLux (Belgium and Luxembourg), the Netherlands, Portugal and Spain appointed new national committees this year, with Kejiwaan Councilor's being replaced in several countries as well. In some places this led to new enthusiasm and fresh energy. In other countries it seems hard to fill organizational positions.

The main topics that delegates report on are internal relationships (the importance of kejiwaan support), how to keep the members engaged, and ongoing issues with property management. Preparations for World Congress were frequently discussed. The passing of older members is sometimes balanced by new openings, but not as much as we would hope for.

Communication and activities

All countries organized successful national congresses/meetings, while Britain also held their most appreciated 'all helpers weekends'.

Subud Britain submitted a bid to host the 17th World Congress in Glasgow, Scotland. A team of 11 members worked on getting the details in place. Britain and Spain presented several proposals for World Congress resolutions, which were discussed during Zone Council meetings on Zoom, and at the in-person Zone 3 meeting in Perth, Scotland in September.

Zonal communication is through the digital magazine Projects & Properties, as well as forwarding relevant news and information by email. Most countries communicate internally through national newsletters, email and / or WhatsApp groups.

Thanks to a healthy financial situation, the Zone was able to substantially donate to the international archives facility project in Canberra (Australia). Delegates and youth were also sponsored to attend the Zone 3 meeting in Scotland.

Wings activities, enterprises and centerprises

On the national level wing activities seem very limited, although events like the British congress and the zonal meeting in Perth included wing and project related presentations and discussions.

A few enterprises are financially supporting Subud in various ways.

Internal relationships, member engagement, property management, and World Congress preparations were key topics for Zone 3 Council members this year.

Strong Susila Dharma projects like Roda Viva (Portugal) and Enthum House (Britain) continue to develop. The Amaranthe eco-village project (France) is still in progress.

In Britain, the Lewes group purchased the Lewes New School after selling their property. The Hague Subud house in the Netherlands was also sold, and the group is looking for alternatives. Some Subud houses can balance their expenses with generating income through rental activities, but in many cases this is challenging.

Membership overview

fter a massive decline during Covid, the number of active members (currently 580) is slowly recovering. Openings are generally rare, except in Russia, Hungary and Israel.

Regular group *latihan* is held in ten countries. Germany, Norway (to meet aged members' needs) and Ukraine (because of war situation) additionally offer simultaneous *latihan* and Zoom meetings. Lebanon, Poland, and Sweden rarely have group latihan, but keep in touch via Zoom and with regular simultaneous latihan.

Local and national *kejiwaan* meetings are held periodically and are experienced as important. Monthly meetings combining latihan, socializing, workshops on chosen topics, small social projects, and meetings open to non-members, are well attended.

Communication and activities

The Zone Council held eight zoom meetings and discussed international topics (mainly preparation for the World Congress) and shared about group life and each country's situation.

The wars that are heavily affecting four countries in the Zone were present as an issue in all our meetings and email exchanges. Simultaneous distance latihan and small meetings with the groups affected were held, supported by the International Helpers and Kejiwaan Councilors.

The Zone 4 meeting was postponed to March 2024 (which was attended by over 110 participants). Three informal meetings 'filled the gap' in 2023. In July, Subud Greece hosted a seaside holiday in Crete, which was enjoyed by 58 participants from 16 countries, and a Subud camp in central Poland was attended by nine participants from three countries. In October, a Zone 4 kejiwaan meeting in Budapest, organized as

a joint Hungarian-Austrian venture, attracted over 40 participants from ten countries. Following the participants' wish, it is planned to hold such meetings annually.

Wings activities, enterprises and centerprises

Since Covid, the five countries who own Subud houses (Germany, Ukraine, Greece, Hungary and Norway) are struggling to build up sustainable centerprises.

There are several local enterprises in Austria, Germany and Israel that are owned by and employ Subud members. The Zone 3/4-wide enterprise, E-Lango, is slowly growing, and watched with interest and hope.

Susila Dharma is active in Germany and Norway: members in Greece and Israel organize charity projects. SIHA is active in Germany, and also offers international SIHA events on Zoom and in person. A Youth dance weekend was held in Wolfsburg (Germany) and will be repeated in 2024. SICA Zoom meetings are attended by country representatives.

Membership overview

ince the last World Congress membership has declined partly due to Covid and members who have passed away. Some members still prefer doing latihan remotely due to age and distances between groups.

However, membership is slowly increasing and there are regular group *latihans*. There were many openings in Malawi and there are now a few candidates in Nigeria and South Africa.

Communication and activities

Africa has always difficulty with communication due to the costs of internet and other factors.

The *latihans* are good and the members listen to Bapak's Talks and are happy to receive books and recordings of Bapak and Ibu Rahayu's Talks. There are simultaneous latihans for those members in remote areas. Many remain in touch with the membership via WhatsApp and Zoom.

The planned in-person Zone 5 meeting had to be canceled. Hopefully there will be enough country members to get together at the World Congress.

Membership is slowly increasing and there are regular group latihans. There were many openings in Malawi and there are now a few candidates in Nigeria and South Africa.

The International Helpers were hoping to travel to Nigeria, but due to Covid and the insecurity in that country their trip was canceled. However, the International Helpers will travel in April 2024 to visit groups in Malawi and South Africa. The next Zone 5 Representative will be tested in during the International Helpers visit.

We hope a few of the Zone 5 country delegates will be able to obtain visas to attend the Subud World Congress in Kalimantan in July 2024. Some members were refused visas and could not attend the last World Congress in Germany.

Wings activities, enterprises and centerprises

Subud South Africa received grants from MSF to help with much needed repairs, and now they have tenants and some income. This in part has lifted some of the financial burden from the membership for the maintenance of their two Subud properties.

Subud South Africa is the only country in the Zone who gives an annual donation to WSA.

While most of the Wings are not formally represented in the Zone, members do participate in enterprise (SESI), charitable (Susila Dharma) and cultural (SICA) activities. For example, some members in Cape Town organized community outreach in South Africa in response to the Covid crisis by cooking soups and food and handing it out in the poorer communities. A number of individual members have their own interests in the arts and music. SIHA is not active in the Zone.

There are a few young members; while they are not active as a Wing, they do communicate with other youth around the world. This has been assisted by Emanuel Mbassi as Zone 5 & 6 Youth Representative.

one 6 has five countries, but only four maintain active contact. We have lost contact with Algeria.

DR Congo has a large and active membership, including many youths in Kinshasa and Matadi. Angola has history of a large membership, but the lack of a Subud house makes it difficult for the members to meet regularly.

Benin and Congo Brazzaville have been able to maintain close contact with DR Congo and Angola, which makes it possible to understand what is happening in those countries.

Overall, despite the passing away of our Zone Representative Mendes Mente, there is a sense of togetherness amongst the members.

Most countries face difficulties in filling all the organizational positions, and lack a Subud house.

Communication and activities

Communication is still challenging in our Zone for many reasons, from financial to social. Although we have been able to maintain communication, there is a lot of work to do.

The highlight of the year was the Zone 6 meeting in September, held in Most countries face difficulties in filling all the organizational positions and lack a Subud house.

the newly refurbished Subud house in Kinshasa. There were 65 attendees. including country delegates from Angola, Benin, Congo Brazzaville, and Congo Kinshasa.

There were 14 resolutions resulting from the last Zone 6 meeting in 2017. These were all discussed, and two working groups were formed to work through *kejiwaan* and committee/project-related resolutions respectively during the meeting. Outcomes included the appointment of a helper to Congo Brazzaville, and the testing and election of Emanuel Mbassi from Angola as the next Zone 6 Representative, who served as the Zone 5 & 6 Youth Representative during this council's term.

Wings activities, enterprises and centerprises

DR Congo has a strong and active Susila Dharma organization there is also an SD project in Angola. But overall there is a lack of formal representatives for most of the wings.

Members in DR Congo are actively involved in building centerprises, like the Kinshasa Subud house.

MENDES LEMBA MENTE

Mendes Lemba Mente passed away suddenly on December 16 2023, in Luanda, Angola. He leaves behind his wife and three daughters.

Mendes served as Zone 6 Representative since the 2018 World Congress in Freiburg, and organized for his work for Subud and the Zone.

America, and the Caribbean

Membership overview

he return of in-person gatherings, National Congresses, and International Helper visits across the Zone have been rejuvenating for members and groups.

Subud USA, for example, held a successful, well-attended national congress in September, and National Helpers hosted a national helper gathering. Subud Canada and Subud Mexico also held national congresses. Subud Caribbean are planning their next national congress for early 2024.

There were also some openings, including 15 new openings in the Caribbean. However, over the past couple of years, more than 10 members have emigrated from the Caribbean including five members of the National Committee.

Communication and activities

Zone council meetings were held quarterly and continue to combine Zoom and WhatsApp so that Subud Caribbean members can participate. Important topics for the Zone in 2023 included increased activities and connectedness, supporting members in the Caribbean, and World Congress preparation. The hope was to hold an in-person Zone 7 meeting in 2023, but the council opted to save funds to send most of its delegates to the World Congress (which was initially expected for January 2024).

Member countries in the zone work together during council meetings, and notably Subud USA and Subud Canada have collaborated on a joint World Congress proposal to host the 17th World Congress. A video and written documentation of this project will be presented at the World Congress in July 2024.

Wing activities, enterprises and centerprises

There are established Susila Dharma (SD) and SICA national organizations in Canada, Mexico, and the United States. Subud Caribbean has representatives for all the wings (SD, SICA, SESI, SIYA) but unfortunately Subud Suriname does not have any

wing representatives at this time. Only Subud USA has a long-term SESI presence, but the Zone is actively encouraging enterprising activities in all member countries.

There are 14 Subud properties in the USA, almost all of which generate revenue. Still, donations are necessary to meet the budget. More than 40% of the Subud USA budget supports pledges to Zone 7 and WSA, and the revenue from centerprises helps this happen. One property is scheduled to be sold due to lack of membership.

In Canada, Subud Toronto, Subud Quebec and Subud Vancouver are involved with the centerprise of their Subud premises. Subud Vancouver is quite successful and now provides financial support for many Subud gatherings and international projects. Subud Ottawa currently has their Subud house on sale due to decline in membership and support.

SUBUD USA'S NATIONAL CONGRESS

ur National Congress felt like a family reunion where about 200 people gathered in person for the first time since the pandemic.

Held in Washington, DC from September 7-11. it was also a business congress where new officers were elected by delegates from across the country.

Finally, we had a chance to tour the Subud WSA archives housed in the Amani Center and experience the new combined campus of the Amani Center and new Twin Oaks property.

The setting for the congress was the Crowne Plaza Hotel, a former Marriott hotel. The property is located in College Park, not far from the University of Maryland campus and 3 ½ miles from the Amani Center.

The Crowne Plaza provided all the spaces we needed—grand ballrooms for the three *latihans* a day, break out rooms for testing, and a dining room that served great food. You could see clusters of Subud members in every corner of the hotel, deep in conversation...

... Some members from the MidWest and even farther regions combined a "great American road trip" with traveling to D.C. Some enjoyed tourist time in the Capital and quaint towns. Not since the 2014 Sofitel Congress in Redwood City were so many members in the mood to attend a national gathering.

We hosted international visitors. These included Suyono Sumohadiwidjojo, WSA Executive and Nahum Harlap, the WSA Chair, plus Hannah de Roo, Zone 3 Representative. Matthew Moir of the

WSA Archives came to confer with the Subud USA Archive team. Rashidah Pope from Canberra, Australia attended so she could use our Archives to complete writing Volume 3 of *The History of Subud*. She is finishing Harlinah Longcroft's lifetime project after Harlinah's passing...

... With meticulous attention to detail by the Congress team (especially Philip Lindstrom and Alexandra ter Horst, our Operations Manager), everything that needed to happen unfolded seemingly effortlessly.

The National Helpers supported the entire event with marathon testing for officers and many roles as well as offering personal testing.

Membership overview

his was a year of reunions.
There was a certain expansion of the *latihan* in some of our countries, and a decrease in others.

Important in-person gatherings were held across the Zone, and moments of joyful and harmony were experienced. The support of international and national helpers was vital.

Communication and activities

The Zone 8 meeting was held in July in Amanecer, and was the first in-person zonal meeting since the pandemic. The motto for this meeting was "Your presence Unites us". There were 193 attendees from Zone 8 and other Zones (7,9,3). It was a harmonious meeting filled with a blessed atmosphere of peace and joy.

In Colombia, the national *kejiwaan* meeting of helpers was attended by more than 100 helpers from Colombia and other countries, and was supported by four Area 3 International Helpers. A Colombian helper donated 100 copies of 'Advice & Guidance for Bapak's Helpers'.

A Colombo-Venezuelan binational gathering was held in Cúcuta. There was *latihan*, helper appointments, an opening, reports, and loving integration.

This was a year of reunions, and important in-person gatherings were held across the Zone. The support of international and national helpers was vital.

Subud Venezuela held its national congress in El Tigre. A new national committee was appointed, which has since updated its constitution. With the national helper *dewan*, the new committee also organized the "First national hug of Subud Venezuela" meeting, with the objective of promoting harmony between the groups.

Subud Ecuador held *kejiwaan* meetings and workshops with all the members of Quito and Tumbaco, which have been fundamental to sustaining the *latihan* and active presence of the members.

Zonal and international information updates were shared by email and WhatsApp. The Zone 8 Council met monthly and discussed the World Congress proposals, and disseminated information about the World Congress organization throughout the Zone. Subud Venezuela created the bimonthly digital magazine 'In Contact', which is published in Spanish and English.

Wing activities, enterprises and Centerprises

There are various business and social projects in the Zone, such as

the Corporación Empresarios en Acción CEA Internacional, Solidhar+contribution and credit cooperative; and a fair for artisan entrepreneurs organized by Fundación Amanecer.

SICA Latin America hosted faceto-face and virtual events, and participated in SICA Explore and the virtual program, 'Sacred Footprints'. Costa Rica provided aid to two Subud brothers with financial needs. The 'Solidarity Zone' program also provided funds via the Zone to assist members.

Subud Youth Ecuador and Colombia provide permanent support as English-Spanish interpreters at WSA, WSC and other board meetings.

In 2023 Zone 8 donated USD 2,600 to the general fund, USD 554 to the Archives, and USD 300 to the WSA Endowment fund. During this term (2018-2023) a total of USD 17,783 has been contributed.

ZONE 9

Membership overview

one 9 is made up of four countries that remain active and are part of the WSA - Argentina, Brazil, Chile and Peru. Additionally, there are active members in Paraguay and in Uruguay; they are growing and hope to soon establish themselves and be part of the WSA.

The countries of Zone 9 have helpers who are very committed to keeping the *latihan* alive in their groups. In Chile and Argentina national helpers visit the different groups to strengthen and support the members.

In general, the groups remain stable in terms of member numbers with occasional openings. Challenges include attracting young people to be more active in Subud and attracting new members.

Communication and activities

The Zone 9 council meets via Zoom approximately every three months to share relevant information from the WSA and the countries, and maintain harmonious communication. Additionally, information is sent to the Zone council via email and WhatsApp to be shared with all members in the countries.

The countries of Zone 9 have helpers who are very committed to keeping the latihan alive in their groups.

The most important thing during 2023 was to share and discuss the progress of the World Congress and the proposals from the member countries.

A key event for the Zone was our first in-person meeting after the pandemic at the end of April 2023. With great joy we saw each other again. We shared the situation of the countries, activities of the wings, news about the world congress and a presentation of the MSF. The Area 3 International Helpers attended, who supported the latihan and testing, and worked with the helpers in the area. We elected our next Zone 9 Representative. Lamberto Arévalo, whose term will start at the 2024 World Congress.

Chile and Argentina had national congresses and helpers visited different groups to strengthen the latihan and the development of Subud in each place. They do an excellent job as helpers.

Wing activities, enterprises and Centerprises

The wings of SICA and Susila Dharma are active on a personal level in every Subud member in the area. At the group level these wings are not

organized into long-term projects, however they are activated in response to specific needs to support members or their community.

As for SESI, Peru and Brazil have developed Airbnb projects in their Subud Houses. The income is used for the maintenance of the houses and helps support delegates to attend local, national or international meetings.

To maintain the Subud house in Mina Clavero, Subud Argentina rents out a bungalow long term. The Buenos Aires house is supported by membership contributions, but this is not enough.

The Subud houses in Chile are supported by membership contributions, which is sufficient. It is not possible to rent space due to tax issues.


ne main aims of the Subud organization are to facilitate the practice of the *latihan* and help members to understand its benefits and how to apply it in their everyday lives.

To further these aims, 18 helpers with an international function are selected by testing for a term that lasts between world congresses.

The International Helpers work in three geographic areas and serve the members across the zones as shown in the map below.

Helpers in the Zones

- Local helpers serve the members of their Subud group and support the group
- Regional helpers are appointed in countries where multiple groups are organized into regions and serve all the members in the region and support the regional council.
- National helpers, including kejiwaan councilors, serve all members and support the national council. Kejiwaan councilors also support the zone council.



INTERNATIONAL HELPER *DEWAN* MEETING PORTUGAL, OCTOBER 2023



he dewan of International Helpers (IH18) met in Porto during the first two weeks of October, in preparation for the upcoming Subud World Congress and to discuss the state of Subud in all Areas.

In order to talk about the *kejiwaan* programme for world congress, the Internal Helper *dewan* held meetings via Zoom with helpers and Kejiwaan Councilors from around the world.

Preparation for the World Congress also included meetings and *kejiwaan* work with WCOT members Rusdi Bustillo and Robiyanto Sumohadiwidjojo, who came over from Indonesia.


Supporting the *kejiwaan*

International travel

WSA Archives facility in Canberra

One of the most important projects of the WSA this term was the construction of the new WSA Archives facility in Canberra, Australia. MSF granted USD 210,468 to the project, which aims to continue safeguarding and digitalizing Bapak's and Ibu Rahayu's talks in a new building equipped with high quality archival conditions.

In further support to the Canberra project, MSF has also agreed to underwrite up to a maximum of USD 95,090 in case full funding cannot be secured for the total project costs, estimated at USD 452,000.00.

MSF makes a special recognition in memory of Harlinah Longcroft, whose bequest earmarked for the new WSA Archives facilities in Canberra contributed to financing 30% of the total costs of the project.

The MSF Board of Trustees expresses its deepest gratitude to the Foundation's donors. The donations and bequests have a significant impact on MSF's ability to support the worldwide Subud community.

MSF portfolio gain of 11.41%

After the drop experienced in 2022 as a consequence of the global economic crisis, the Foundation's portfolio recovered 11.41%.

This result has been possible thanks to the work of the Investment Committee and its professional portfolio manager, Helene Jelman. With her expertise, the team adapted to and navigated the economic crisis with a strategic approach to portfolio recovery.

Ensuring a smooth transition to the new board of Trustees

To ensure a seamless transition after World Congress, the current team will collaborate closely with the new trustees, facilitating knowledge transfer, strategic alignment, and a smooth handover of responsibilities.

MSF thanks the five trustees who have dedicated almost six years to serving the Foundation, and a special acknowledgment to Lucian Parshall, who has graciously agreed to continue supporting the new Board as a consultant whenever required.

Fundraising and project support

We continue to support inspirational development projects from around the world, with the emphasis on living in harmony with the natural environment, organic agriculture, health, social welfare and access to quality education.

SDIA was able to raise USD 284,359 for projects and services, and everage significantly more funds by coordinating the efforts of the SD network. SDIA reinstated the SD Grants matrix providing information to all SD nationals on active project requests and what they needed to be fulfilled.

SDIA supports Subud members who feel guided from within to take action in the world through social and humanitarian projects.

Communicating, learning, and sharing our experiences

Sharing the experiences of SD practitioners is important for learning and exchange within the SD Network and with the wider Subud community. In 2023 SDIA organized:

- Three SD Passport Sessions virtual visits and exchanges with practitioners.
- · Four Inner Leap Training Sessions for SD Network members including use of social media, development of SDIA's Environmental policy, and two *kejiwaan* sessions with the International Helpers.
- Four eNews magazines, as well as the Subud Emergency Fund appeal for the Ukraine.

Collaborations

The SDIA team is grateful to the International Helpers, particularly our liaisons Benedict Hermann and Illène Pevec, with whom we collaborate on a regular basis.

Several of the SDIA team attended the WSC meeting in Kalimantan in February to foster closer relations with the Zone Representatives and WSA Executive team. Being together with our fellow Wing representatives was a

wonderful opportunity to start working on joint plans for the forthcoming World Congress in 2024.

In May we collaborated with the WSA Executive team on a joint fundraiser for WSA's Care Support fund, which raised approximately USD 12,000.

SD representatives attended the Zone 3, 6 and 8 meetings during 2023 and presented on some of the developments in the SD world.

Environmental Strategy: We've been progressing our Environmental Sustainability Strategy with the help of Indra Halviala and Illène Pevec. Our aim is to reduce our climate impact and protect the natural environment as much as possible, in the varied ways that we each operate.

Subud Education Association (SEA): We continued to provide an institutional home for, and closely collaborate with, the SEA team, a sub-committee of SDIA. They have run several successful online seminars throughout the year and held an AGM. Their focus is on sharing and supporting educational best practice, and encouraging Subud members in their educational endeavors in the world. They have administered emergency grants to several members in need with their education.

Human Force - Youth Engagement:

A youth volunteering camp was organized at Amaranthe in South West France, where several Subud members are building an eco-village. The camp was attended by 15 young people, which included building workshops and a hiking trip.

Challenges

The needs of SD projects are great and the engagement of Subud members in the social fields is strong, but we can't reach our potential unless donors stand with us. We are grateful to all the Subud members who are there to support this important aspect of Subud's presence in the world, and invite more to join us! Supporting SD is not just about giving money, but also giving of oneself and one's talents, time and connections.

World Congress preparations have taken a great deal of time and the need for coordination is very demanding. One of our primary aims is to coordinate visits to the SD project members based in Kalimantan, so that congress participants can witness firsthand the amazing projects that Subud members have started, understand the issues involved, and perhaps feel moved to start something of their own.

SICA's purpose is to encourage and support the development of programs, projects, and events that allow people to connect with and express their true inner talents in the world.

SICA Chair: Rusydah Ziesel

Aims and objectives

e believe in the discovery and development of individual talent and potential in a respectful and supporting environment. SICA provides information, training, networking, and support services as well as opportunities to engage and collaborate with cultural initiatives and events around the world.

We continue to seek to bring awareness of the purpose of SICA – it is not only for artists; we are a cultural organization, and for us that means we are firstly an educational organization.

We are working together with Helpers on all levels to support members to become aware of their culture and gifts to the world.

We organize cultural events like Poems for Peace and musical concerts to fund raise and help strengthen the SICA organization.

We continue to strengthen SICA's relationship with Youth. We are

building an academy platform on our website, with the aim of helping youth in recognizing their talents and bringing them into the world.

Activities and achievements

We held SICA Country meetings with *latihan* every two months to exchange about projects. In our role as a 'network of networks' we assist countries where required, and have built a service platform on our website with a resource list for countries and members: subud-sica.org/services/

SICA Latin America continued with its program of virtual culture events, including workshops and activities. with themes such as faith and action. and contributed to the Zone 8 meeting with videos and performances.

SICA Europe was registered in Austria.

Our new SICA Explore project was launched, where Subud members share their projects and experiences via Zoom. This initiative is being led by Andrew Hall and Susheel Balasubramananiam.

The participatory youth conference initiative, Culture Bar Camp, was held in Spring and Autumn, in which participants determined the content and program.

Challenges

Finances continue to be a challenge. WSA Treasurer. Hannah Baerveldt. supported the SICA Board with ideas and an action list that was very helpful.

The Subud Village has been discontinued. To date it had been financed by SICA board member, Ismanah Schulze-Vorberg, however we have been unable to secure alternative financing.

Collaboration

We have worked closely with the other Wing chairs to prepare for the 2024 World Congress and have regular Zoom meetings.

Aims and objectives

ESI's aim is to improve the financial strength of our Subud organization by inspiring and facilitating the development of both small and larger-scale collaborative Subud enterprises.

Our objectives are to:

- · Inspire and help develop largerscale enterprises
- Support new and existing enterprises
- Promote centerprises and enterprises worldwide via our e-newsletter and the SESI website
- Continue developing an enterprise expert panel
- · Build the SES national representative network
- Encourage Subud enterprises to donate to WSA and SESI

Activities and achievements

We published our e-newsletter issues 14 and 15, which are circulated to 2500+ readers. These feature new and established enterprises of Subud members to celebrate innovation and

our entrepreneurial spirit, and call for financial support of WSA and promote World Congress. View these and past issues at subudenterprise.com.

SESI supported SICA and SIHA to develop a combined database of Subud Talent, experts, advisors, professionals, and businesses.

Work continues on planning and building our SESI Panel of Advisors. We continue canvassing for more to join.

SESI encourages national SES representatives, who are a vital part of our worldwide 'communication' web.

Usaha Mulia BV (re-activated by our previous SESI Chair) was de-activated because it proved 'not fit for purpose' and too expensive to maintain.

Challenges

In 2023, the WSA budgeted USD 1,300 for SESI (from Restricted Funds), which just covered our SESI e-newsletter and website costs. Thus the SESI Co-Chairs were unable to travel during 2023.

In person meetings are essential in building a strong, productive international Enterprise body and far more effective than relying on Zoom and WhatsApp calls, which remained the main ways of connecting in 2023.

Collaboration

SESI continued actively working with the Wings to develop our World Congress programs. The uncertainty of the Congress dates made this a stop-start process however the Wings maintained communications throughout 2023. Our collaboration led to a joint proposal for a Congress Wings Hub, which includes:

- · Latihan at the center
- · Integration of Wings activities (with no individual Wings 'silo' approach, as happened previously)
- Working together to create the Hub

SESI volunteered to raise money to prepare the space for Wings Congress activities, and to improve the latihan facilities as a legacy for the local Rungan Sari group.

SIHA continues to strengthen its organization and develop closer links with the international organization, and provides a range of services to Subud members.

Aims and objectives

IHA is committed to providing health-related services, fostering community support, and promoting well-being among Subud members and others on a world-wide basis. Our aims include:

- Establishing SIHA as a charitable trust in Britain to enhance accountability, facilitate fundraising, and to undertake projects.
- · Strengthening collaboration with the WSC, other Wings and WCOT, and to establish closer links and a symbiotic relationship with the Mental Health and Crisis group.
- Expanding and supporting the SIHA network of national and zone representatives and encouraging broader outreach and support within the Subud community.
- Offering various online services to Subud members.
- Promoting the SIHA website and establishing a regular newsletter.

Activities and achievements

Throughout 2023, SIHA organized a diverse program of online activities for its members. Objectives

SA Archives is a service of and reports to the WSA executive committee.

The mission of the WSA Archives is to collect, manage, and preserve for posterity:

- The work of Bapak Muhammad Subud Sumohadiwidojojo, the founder of Subud, in its original form together with the evidential and contextual basis for that work.
- The work of Ibu Siti Rahayu
 Wiryohudoyo in its original form
 together with the evidential and
 contextual basis for that work.
- Those records giving evidence to the historical development of Subud and as normally archived by an organization of global significance.

Organization

The WSA has five international Archive Centers:

Cilandak, Indonesia: This center, located in Wisma Subud, is administered and funded by Yayasan Muhammad Subuh (YMS). The primary collections are the talks, letters, and writings of Bapak and of Ibu Siti Rahayu.

Canberra, Australia: WSA Archives Canberra is the only center entirely funded and directly administered by the WSA. It is designated as the primary location for all international collections focused on the history, development, organization, activities, and spread of Subud. It also houses the original and unedited raw audio tapes of Bapak's talks from the WSA Tape Preservation Unit and the derivative digital files.

USA and **Britain**: These centers hold the national archives of their countries along with important international records.

Japan, along with each of the other WSA Archive Centers, holds a set of the early back-up archival materials distributed in 1979 and the microfilm distributed in 1993, and the LTO's of Bapak's talks.

WSA ARCHIVES

(Continued)

A concept plan for a purpose-built climate-controlled facility for WSA Archives Canberra in Australia was approved by the WSC in February. Fundraising took place throughout 2023. We are deeply grateful for the generous and widespread financial support for this long-awaited and milestone project.

Activities and Achievements

Canberra purpose-built facility

A concept plan for a purpose-built climate-controlled facility for WSA Archives Canberra was approved by the World Subud Council in February 2023. This was for a working space/office and three insulated 40 ft container repositories enclosed within a shed, located on the grounds of Subud Canberra.

Detailed plans were submitted to the ACT/Canberra planning authority in May and Development and Building approvals were granted in December. Construction will begin in January 2024 and is projected to be completed by late May or June. The cost of the project will be US\$455,672.

Fundraising was conducted throughout 2023, and the project was fully funded by year end. A generous bequest of USD 141,416 from Harlinah Longcroft provided a strong foundation for this effort. WSA provided a further USD 79,626, an amount equivalent to to the Lavinia Sinclair bequest.

Generous grants and donations have been made by MSF, Subud Australia, Subud Sri Lanka, Zone 3 and Zone 8. In addition, members have donated a total of US\$121,251 through the Friends of the Archives. We are deeply grateful for the generous and widespread financial support for this long-awaited and milestone project.

WSA Living Archives project

The WSA Living Archives project to digitize assets of archival value and to store and provide managed access to these on the Preservica preservation platform has continued. We now have a digital archives team of six to manage the various elements involved in this venture.

Ultimately, we envisage digitizing significant records from each of the major international archive centers, the national collections of member countries, and the archival and operating records of the WSA and its entities and affiliates.

Amani Center

There has been continuing active and ongoing work to organize and digitize the national and international archival collections of Subud USA since these were moved to a climate controlled archival facility in the Amani Center, Subud Washington DC.

WSA Archives Strategy

A productive WSA Archives Strategy meeting was conducted at the Amani Center in September 2023, hosted by the Subud USA Archives Council. This was a hybrid meeting that involved members of the WSA Archives Subcommittee, the Subud USA Archives Council, the digital archives team, and International Helpers.

ubud Pulications International (SPI) continues to transcribe and translate Bapak's talks from the existing audio recordings in order to provide future generations with Bapak's guidance and explanations. The recordings are being tran-scribed and translated from Indonesian into English and other languages.

SUBUD PUBLICATIONS INTERNATIONAL (SPI)

Subud Publications International (SPI) is an independent charity, registered in the UK, and run by Subud members.

Activities and achievements

In 2023 SPI published Volume 41. The translations for Volume 42 were also completed for publication in 2024. This edition covers the last part of Bapak's Longest world journey in 1972

Volumen 31 – Spanish edition, was completed for publication in 2024.

The existing translation of Susila Budhi Dharma was reviewed and revised for a pocket version.

Challenges

One of our challenges is to prepare ourselves for the future and to find skilled and dedicated members, preferably in the UK, who could participate in taking over tasks such as managing our stock, our bookshop at congresses, and sales and shipment of books.

Another challenge is to locate missing audio recordings from the year 1975 in The Hague and Eindhoven, Netherlands, which are required for the revision of Volume 1. This includes talks of Bapak in the very beginning stage of Subud in the West. The recordings are believed to be in Indonesia. The Tape Preservation Unit helped in tracing the possible location of these recordings through extensive research.

Collaboration

SPI works closely together with the Tape Preservation Unit (TPU). The TPU plays an essential role in providing SPI with detailed information and research about talks and recordings by Bapak.

SPI collaborates with the WSA Translation team and supports the translation of talks in other languages.

TRANSLATIONS

FINANCIALS 2023

To deeply understand the work of translations, all of us who work on it - WSA Archives, transcribers, translators, proofreaders, publishers, SPI, Subud Library, and national committees - recognize that: Bapak's and Ibu's words contain quidance and wise counsel for those of us practicing the latihan kejiwaan of Subud and deserve all the respect and care we can give so that, neither now nor in the future, the message be misrepresented.

Aims and objectives

e aim to make Bapak's Talks and Ibu's Talks available to Subud members in many different languages.

Our objective is to make sure that the translations are accurate. We follow a procedure to assure the reader that the source of the translated talks is authentic, traceable, and in accordance with what their authors said and wrote.

Activities and achievements

In 2023 we subtitled three video talks in Indonesian, French, Spanish and English: 68 TJK 6, 70 WOB 3 and 83 LON 14.

The Advice and Guidance for Bapak's Helpers was printed in Indonesian.

Source classification and authentication

The WSA is responsible for demonstrating the authenticity of Bapak's words.

Together with the Archives, Ibu's Office and SPI we produced a document, Identify the Types of Sources of Bapak's Words, to assist in differentiating what "Bapak says" from what "Someone says that Bapak says".

We have:

- Direct sources: "Bapak says..." in recordings, writings (Susila Budhi Dharma, Autobiography, Letters, writings in *Pewartas*), and transcriptions in Indonesian / English of lost recordings.
- Indirect sources: "Someone says that Bapak says...", such as in notes of a non-recorded or lost talk, or an account of a talk (written within a short period of the given talk), or memoirs (i.e. books or articles written by Subud Members).

TRANSLATIONS SUBCOMMITTEE:

WSA Coordinator of Bapak's and Ibu's talks in all languages: Elisa Sánchez-Caballero

We work with the translators of the different languages, proofreaders, editors, SPI team, Archives, Subud Library, Ibu's Office.

Prior to this classification of sources there was confusion as to whether Bapak's words from indirect sources were authorized by the WSA. The WSA can demonstrate the authenticity of Bapak's words for the direct dources, and the authenticity of the documentation for the indirect sources.

Challenges

We are continuously aiming to improve the quality of the translations. We are always reminding everyone to quote Bapak's words as explained in the Guide to Referencing Quotes from Bapak's Talks and Ibu's Talks, and to always mention the source reference so readers know where a quote or excerpt has come from, and thus be confident of its integrity.

Collaboration

We continue with translators' workshops via Zoom, in which translators of all languages meet to share and discuss the challenges they face in translating Bapak's talks.



2023 Financial Review

f one views only our Cash Position at the end of 2023, WSA looks quite well off with assets totaling USD 1.045.009. However, looks can be deceiving! More than half are "designated funds", meaning they can only be used for very specific purposes.

For example, USD 145,596 is reserved for World Congress preparations and once expended, needs to be replenished with income from the World Congress so that the next administration will have it available for their congress set-up. The balance of designated funds amounting to USD 337,830 mainly constitute the funds dedicated to paying for the construction costs of the new Archives facility at Canberra.



This leaves us with less than half of that wonderful million dollar image, just USD 427,404. And, in 2024, with the end-of-term activities increasing as the World Congress approaches and the expected completion of the Archives facility at Canberra, the demand for funds will most likely fully deplete what we currently have in the bank. We therefore look forward to robust donation levels next year.



The WSA Endowment Fund

In 2023, the WSA collected USD 6,294 in donations to the WSA Endowment Fund held and managed by the Muhammad Subuh Foundation. The funds have not yet been transferred to MSF.

Ultimately, the Fund will be able to contribute annually to the WSA budget to preserve Bapak's talks and archives, update translations, enable international helper travel, and protect our copyrights and trademarks.

GLOSSARY:

Preserved Value (PV): Long term value of the endowment adjusted annually by the rate of inflation.

Total Value: Long term value plus/less the distributable value.

Gain/Loss from investments: Change in the value of the endowment's investment portfolio over a period of a year. MSF invests in a diversified portfolio of assets, such as stocks, bonds, with the goal of generating long-term growth and income.

Donations: Gift of money or assets that is made to MSF.

Admin Fee: Fee discounted from the endowment to cover the costs of administering and managing the endowment.

Opinion
